यह राजीनामा आज दिनांक 29/10/2023 को जयपुर शहर में श्री **विजय रोहिला**, निवासी वॉर्ड नंबर-07, नियर ओल्ड पुलिस स्टेशन, राजस्थान राज्य का, जिन्हें इस लेख्य पत्र में प्रथमपक्ष शब्द सम्बोधित किया गया, **समनरायण जाट पुत्र श्री भगवान लाल जाट**, निवासी जाट मोहल्ला, चित्तौड़गढ़, राजस्थान राज्य **एवम् श्री अमान खान पुत्र श्री हसन खान**, निवासी हिब्यापाड़ा, वॉर्ड नंबर-23, जैसलमेर, राजस्थान प्रान्त के जिन्हें इस लेख्य पत्र में द्वितीयपक्ष शब्द सम्बोधित किया गया है के मध्य निम्नलिखित शर्तों पर लेख्य किया गया है।

1. यह कि प्रथमपक्ष व योगेश बॉक्सर उर्फ योगेश शर्मा, प्रियांशू नेहरा, आयुष तिवारी उर्फ जितेन्द्र शर्मा, नरेश राठौड़, लक्षित यादव के मध्य दिनांक 03/10/2023 को महात्मा गांधी हॉस्पिटल के सामने स्थित चाय की थड़ी पर मारपीट व झगडा हो गया, जिसमें उपरोक्त व्यक्तियों द्वारा अकारण ही प्रथमपक्ष के साथ मारपीट की, जिसमें प्रथमपक्ष को काफी चोटे आयी।
2. यह कि उक्त मारपीट प्रकरण के संबंध में प्रथमपक्ष के द्वारा शिवदासपुरा थाने में उपरोक्त वर्णित व्यक्तियों व द्वितीयपक्षगण के खिलाफ एफआईआर रिपोर्ट दर्ज करवाई गई।



The committee members convened to find out the facts about the matter that occurred on 04/10/2023.

Findings & Recommendations based upon the Investigation:

After conducting a thorough investigation, the committee concluded that the mentioned students were expelled from the college due to involvement in a fight and a complaint made by a student from a nearby college. At first glance, it appears that the student involved in this incident is attempting to harm the academic reputation of the institution.

The committee urges the administration to take strict action against the students. It also recommends that parents of such students visit the college, get to know the committee members, and monitor their children to prevent similar incidents from occurring on campus in the future.
