Sub.: Special Instructions for booking of UM Cases at Examination Centres

Sir,

While forwarding of UM Cases booked at the centre, following instructions must be followed strictly as UM Case is a legal document and also very much related with the career of the students:-

- It has been observed, while dealing with the UM Cases by Unfairmeans Committee, that some of the Centre Superintendent (C.S.) did not sign/ put his Seal at prescribed place. No case of unfairmeans will be considered for further action without signature & seal of Centre Superintendent. UM evidence must be enclosed essentially.
- In some of the cases the observations of Room Superintendent were not 2. certified by the C.S. So it must be taken care before forwarding the case.
- Completely filled up form of reporting cases regarding unfairmeans cases 3. should be submitted. While filling up of UM Proformas, utmost care should be given so that UM Committee may take right decision in the case and innocent student may not punished.
- UM Cases booked at the centre must be dispatched to the Controller of Examination on same date by registered / speed post only enclosing all the related documents in the envelope and Form No. RTU/Exm/313 must be pasted on the top of the envelope.
- Many times it is observed that recovered material is not signed by room 5. invigilator and centre superintendent, even number of pages of recovered material is also not recorded in the C.S. report. So, it may strictly ensure at C.S. level that all pages should be signed and no. of pages should be recorded in detailed C.S. report.
 - Bringing Cell Phones / Communication devices / Programmable Calculators in the examination hall is strictly prohibited. This fact may also brought to notice of students that using unfairmeans are liable to be punished by suspension /expulsion.
 - Print of contents (cheating material) contained in electronic gadgets should be enclosed for ready reference. In case of seized electronic gadgets (mobile phone, digital watch, bluetooth device etc.) password should be mentioned in reporting form failing which UM Committee is not in position to decide the case. - It has also been observed that some cases are booked in the toilet or outside the examination hall. In order to minimize such cases, Centre Superintendent must pass the instructions to Room Superintendent for ensuring proper escorting and strict vigilance on such places be made. Toilets and surroundings should be searched thoroughly before commencing the examinations and regular cleaning should be made during examinations.
- Instruct all the students not to write any thing such as Mobile No., E-Mail ID or any contact details etc. inside the answer books which may disclose their identity.
- 10. Aware all the students regarding unfairmeans activity & their consequences before commencement of examination.
- 11. In case student is booked under unfairmeans during examination, new answer book should be issued to him/her immediately for the remaining period of examination. In addition to this, student be advised to answer remaining part of questions in the second copy. To be more clear, no repeatation is required in second copy. Both answer books should be marked as UM COPY-1 and UM COPY -2 and send separately as mentioned in above point no. 4.
- 12. All the instructions regarding unfairmeans should be pasted on Notice-Board of examination centre and also at visible places of inside & outside of Examination Hall.
