

- The Director explains the requirement and need of ST/SC/OBC Monitoring Cell in any institute in which a person belongs with such category may report his/her issue direct to the cell and the cell members ensures secrecy of such issue and try to resolve on priority.
- > The committee members were instructed by the authority to spread awareness about such cell among students.
- > The committee members discussed about examples of some cases that may be reported in such cell.
- The Chief proctor reported that till date, no any case reported ST/SC/OBC Monitoring Cell.
